

# **Carbon Reduction Plan**

#### **Commitment to achieving Net Zero**

Adsum is committed to achieving Net Zero emissions no later than 2050.

#### **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

This is the first time Adsum has calculated its green house gas (GHG) emissions, and the measurements taken will form the baseline for future reports.

#### **Baseline Year: 2021**

The accounting methodology used follows the standards of the Greenhouse Gas Protocol (GHG Protocol) and ISO 14064-1:2018. The calculation of the methodology was assessed and verified by Carbon Action in September 2021 and was found to conform with ISO GHG principles of being transparent, relevant, accurate complete and consistent.

The baseline measurement covers the seven main GHGs that contribute to climate change, as covered by the Kyoto Protocol. Emissions arising from entities under the operational control of Adsum have been accounted for, and certain Scope 3 sources were excluded.



## **Emissions Reduction Targets**

In order to continue our progress to achieving Net Zero, we are working on carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 70 tCO<sub>2</sub>e by 2026. This is a reduction of 13%
